# A Six-Months Master programme in International Accounting and Finance for Members of Recognized Professional Accounting Bodies

As a qualified accountant, you are just a step away from achieving a Master of Science Degree in International Accounting and Finance (MSc IAF) from Buckinghamshire New University (BNU). You can earn 120 credits towards your Masters if you are a full member of any one of the professional accounting bodies listed below, even if you do not hold a first degree. You would only have to complete 60 credits to fulfill the requirements of the MSc IAF. Applicants holding full professional membership of one of these bodies would be able to complete the programme by studying (1) an independent preparatory course on research methods offered by ABRS and (2) our BNU online master degree dissertation.
